In 2022, the Saint Paul Area Association of REALTORS® (SPAAR) REALTORS® Charitable Foundation will grant up to five \$2,000 scholarships to children or grandchildren of current, active SPAAR members. (At least one scholarship may be designated for the child or grandchild of a SPAAR Affiliate Member.) Scholarship recipients will be selected based on school and community activities, personal recommendations and an essay.

Scholarship Eligibility:

Applicant-student must be the child or grandchild of a Saint Paul Area Association of REALTORS® member in good standing.

Applicant must submit a completed application, essay and two letters of recommendation for consideration.

Eligible students must plan to attend a two- or four-year college/trade school as a continuing or new student in the fall of 2022.

Previous scholarship recipients are NOT eligible.

Relatives of Selection Committee for the Foundation are not eligible.

Decisions of the Selection Committee for the Foundation are final.

Application Deadline

The application deadline is Friday, April 29, 2022. Completed applications and supporting documents must be received by this date.

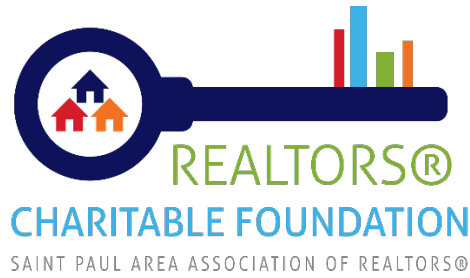
